Conditions and Agreement on the RDA Research Associate Fellowship Program

This agreement has the following conditions to be agreed upon between Director General of National Institute of Animal Science, Rural Development Administration, hereinafter referred to as "A" and the research associate, Dr. SOUNDHARRAJAN ILAVENIL, hereinafter referred to as "B".

1. Title of research project

Technique development for manufacture and quality improvement of triticale silage

2. Period of contract

- a. "A" employs "B" from February 1, 2018 to December 31, 2022 as research associate.
- b. "A" can exercise the right to discontinue the contract even during the agreed period if "B" breaches any condition of Article 14, "Directive on the RDA Research Associate Fellowship Program".

3. Right and status of research associate

He/She is considered as a research fellow as per the "Law for Promotion of Fundamental Science".

4. Working hour and place

- a. "B" should observe the Rural Development Administration's working hours as stipulated in "Directive on the RDA Research Associate Fellowship Program".

6. Possession, Authority, and Publication of Outcomes

- a. Outcomes obtained from the RDA Research Associate Fellowship Program by "B" shall be owned by National Institute of Animal Science, but those obtained from any external project will be decided on the basis of the external body's rules and regulations.
- b. "B" can not publish any outcome from his or her Fellowship Program without the consent of "A". In this case, the following acknowledgement shall be included: "This study was supported by the RDA Research Associate Fellowship Program of National Institute of Animal Science, Rural Development Administration, Republic of Korea."

7. Payment

"A" should pay "B" a stipend of 3,000,000 Won on every 5th day of every month.

8. Appendix

- a. "A" should support the trainee's welfare including industrial accident compensation insurance, health insurance and national pension service for "B" while the contract is in force.
- b. If there are conflicting interpretations between "A" and "B" of the provisions and/or terms in this "Conditions and Agreement on the RDA Research Associate Fellowship Program", "A"'s interpretation will be adopted.
- c. Three copies of the "Conditions and Agreement on the RDA Research Associate Fellowship Program" will be signed by both "A" and "B". Each party will keep a copy and a copy should be submitted to the Administrator of R.D.A.





It can take about two (2) weeks to complete the entire registration process, and so it is necessary for you to have enough money, at least for one (1) month, to live comfortably on until your first (1st) payment can be made.

You will be responsible for all your personal living expenses, including accommodation. The Fellowship does not include pension contributions or housing subsidy.

It is important to secure accommodation before arriving in the Republic of South Africa. The University provides a range of accommodation about which you can read more at <http://www.wits.ac.za/accommodation>. If you need more assistance with securing accommodation, please contact your Host.

The University will also cover the costs of your medical insurance, called medical aid in the Republic of South Africa. This will be provided by a private company called *Discovery Health*. While this medical aid may be extended to any dependents accompanying you, you will have to take responsibility for the additional premiums - the University will only pay for your personal cover. We will process your application for medical aid on your arrival at the University. Please note that should you not make use of our medical aid benefit, you will only qualify for a pro-rata amount to contribute towards your medical aid on condition that you are on another medical aid. In this case, you will have to provide us with a valid medical aid membership certificate. If not, you will not qualify for the pro-rata amount.

The duration of the Fellowship is for twelve (12) months, starting from 1 June 2018, and ending on 31 May 2019. Your future at the School of Molecular and Cell Biology will be discussed with you by your host.

For Non-RSA citizens/Permanent residents:

If you are neither a citizen nor a permanent resident of the Republic of South Africa you should secure a visitor's visa endorsed to conduct research at the University of the Witwatersrand, Johannesburg before resigning from your present post or making any travel bookings. In this regard, I would suggest that you consult the South African Government website at <http://www.dfa.gov.za/webmissions/index.html> for details of your nearest consular representative.

You may be asked by the Consulate to lodge a deposit equivalent to the cost of an air fare from the Republic of South Africa back to your home country. If this does happen, please ask for it to be waived, on the basis that the University will carry the cost, should the South African Government decide, for whatever reason, that you must leave the Republic of South Africa. Please do not be alarmed by this stipulation - we have never yet had a postdoctoral fellow deported. You are also advised to ensure that your passport is valid for no less than 30 (thirty) days after the expiry of your Fellowship and that the passport must contain at least one (1) unused page (i.e. both sides of the page must be unused) for entry/departure endorsements (sometimes referred to as a visa page).

In order to maximise the impact of the University's limited resources, recipients / Fellows of the URC Postdoctoral Fellowships are urged to seek other sources of external funding, especially from the National Research Foundation (NRF). Those Fellows whose research falls within the science, health or engineering fields are also strongly encouraged to apply for external replacement funding but more specifically, but not limited to, the Claude Leon Foundation (CLF). Should the URC Postdoctoral Fellow be offered either NRF, CLF or any other external funding, then the Fellows are required to accept such funding whereupon the

URC Postdoctoral Fellowship will automatically revert back to the Research Pool and be replaced by either the NRF, CLF or any other external funding accordingly. In the event where the external funding is less than the current URC funding, the Fellowship will be topped up to the standard URC level. The Research Office will send you and your Host information on these and other available fellowships at the appropriate time.

On arrival at the University, you must report firstly to your Host, and as soon as it is convenient thereafter you should pay us a visit at the Research Office which is to be found in the Senate House, 10th floor, at room 10022. At that stage, I will help you to open a bank account, explain the method of payment of your stipend and attempt to answer any other questions you may have.

Finally, I enclose the University's conditions of service for Postdoctoral Fellows. This is for your perusal, the acceptance of these conditions by way of signing can be done once you arrive at the University, but no later than the date on which you lodge your first stipend claim.

Please confirm by no later than 22 May 2018 your intention to take up the offer of this Fellowship by completing and signing the reply slip on the last page of this letter. It would be best to scan the letter and email it to me at the address shown above.

If I do not receive a response from you by this date, I will assume that you do not intend to take up the offer and I will make the Fellowship available to the next candidate.
