
Background Verification Process Flow

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding ("MOU") is intended to promote international cooperation between, Universiti Malaysia Pahang (UMP) and the PRIST University. UMP and PRIST recognizing the benefits to their respective universities from the establishment of institutional links, hereby agree to enter into this agreement for the following purpose.

Whereas:

3. IMPLEMENTATION

4. DURATION

 - (i) jointly by the Parties or research results obtained through the joint activity effort of the Parties, shall be jointly owned by the Parties in accordance with the terms to be mutually agreed upon; and
 - (ii) solely and separately by the Party or the research results obtained through the sole and separate effort of the Party, shall be solely owned by the Party concerned.

- c) Both Parties agree that the provisions of this Article shall continue to be binding between the Parties notwithstanding the termination of this Memorandum of Understanding.

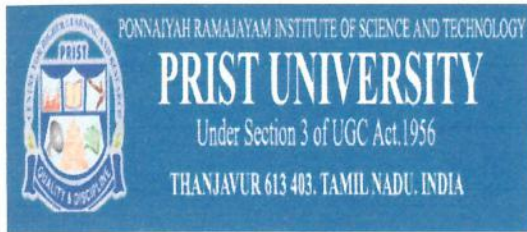

Memorandum of Understanding

1. Preamble

- a) Prist University, Tanjore, TamilNadu and Binary University, Malaysia, are willing to enter into and formally establish this "Memorandum of Understanding" (hereinafter referred to as MOU).
- b) The purpose of this MOU is to promote and expand international understanding, development, and friendship as well as stimulate and support academic pursuits among the students and faculty of the two Institutions. Prist University and Binary University (hereinafter referred to as PU and Binary respectively) identified general areas of mutual interest that may include but not limited to the following:
 - student exchange programs
 - faculty exchange programs
 - Corporate academic program
 - cooperative/collaborative research projects
 - exchange of publications and
 - short-term training, workshops, seminars and conferences.
- c) Both institutions realize that in general the language of instruction is English. The term "host" institution refers to the Institute/University the student or faculty member plans to visit. The term "home" institution refers to the Institute/University where a student is studying or, in the case of faculty Members, refers to the university where the faculty member is regularly employed.
- d) Both institutions understand that this MOU is not exclusive and each institution is

permitted to enter into other such agreements with other universities.

2. Term of the MOU

The term of this MOU shall be five years (2019 - 2024) from the date of signing. The MOU may be renewed for additional periods by written agreement of the parties, prior to the end of the initial five-year term (or any subsequent extension of the MOU). During the initial five-year term (and subsequent extensions, if any), the parties shall consult at least annually to discuss the program, any problems that have arisen, and opportunities for improvement.

Either party may terminate this MOU at any time (during the initial five-year period or any extension period) by giving six months advance written notice.

3. Contact Person

Both the institutions will designate contact persons assigned with the responsibility of coordinating MOU activities in general terms. **For PRIST University, this will be Director for International Relations. For Binary University, this will be Mr.A.AhamedRiaz, Binary University's Regional Director for South India.**

4. Scope of Co-operation

While a wide range of activities, in the academic field is identified within the MOU, any specific program will be addressed under separate written agreements between the two institutions which will serve as appendixes to this MOU. Below are the 3 specific areas of co-operation that will be implemented in Phase 1.

4.1 Student Exchange

- a) Participation in the student exchange programs is meant for advanced skilling, training and gaining advance knowledge and does not constitute admission into any academic degree program or lead to the award of any academic degree at the host institution, unless otherwise permitted under the various rules and regulations governing such participation in both the countries.
- b) The acceptance of exchange is conditional on obtaining the necessary immigration and travel clearance from respective government authorities in the host country and the host institution will endeavor to assist in obtaining proper documents and will guide each student through the respective immigration and visa procedures. However, immigration matters are the responsibility of the exchange student.

4.2 Faculty/Staff Exchange



- a) The faculty/staff of an institution under the terms of the MOU may participate in a variety of activities at the host institution. Such activities may include faculty exchange for instructional and/or research activities for short term or extended periods of time; conducting conferences, seminars, workshops, training programs and/or lecture series; providing professional expertise as consultants on special projects within the institutions.
- b) Unless specifically agreed, each faculty will bear the cost of participation that will be charged by the host university.


4.3 Joint Research and Development


Binary and PU agree to conduct joint research, hold conferences, seminar and workshops to promote academic and research excellence for both institutions.

This MOU will be subject to compliance with all governing rules and regulations in the respective countries.

The institute offers undergraduate and postgraduate courses in Engineering, Science, Education, Management, Arts, and Law, as well as research programmes. herein after referred to as **PRIST** represented by its **Registrar**, which expression shall, where the context so admits, be deemed to include his/her successors, executors and administrators on the **ONE PART**

&

M/s BRIDGE Bharat Council for Promotion of Innovation, Research and Entrepreneurship (BRIDGE Bharat Council), #139/1B, nRoot Headquarters, Near Air Force Station Thanjavur, Pudukkottai Road, Thanjavur-613403, Tamil Nadu, which is an action-oriented think-tank (Section-8 Company) patronized by Senior Military Officials, Industrialists & Educationists, Associations and working towards bridging the gap between the requirements of the Indian Armed Forces and the needs & capabilities of the industry in collaboration with the academia, represented by its Director, which expression where the context so admits, be deemed to include his successors, executors and administrators on the **OTHER PART**. PRIST & BRIDGE Bharat Council will henceforth be referred to as the '**Parties**'. Accordingly, the Parties have decided to enter into this MOU.

Both the parties are agreeing to establish a cooperation program in Collaborative R&D, Academic and Industry related projects to ensure Technological Advancement in the field of Defence and Civil Sectors. Both parties have agreed to the following: -

1. Based on the principles of mutual benefit and respect for each other's independence, the two organisations will foster: -
 - (a) Academic and research collaboration in the areas of mutual interest by effectively employing resources available as well as the infrastructure envisaged to be added by both the parties.
 - (b) Guiding and grooming of faculty members, research scholars and students of all departments, Centers of Excellence, Incubators and Accelerators, to become successful entrepreneurs.
 - (c) Cooperation in Defence and Civil related (Make in India) projects, students' internship, Faculty Enrichment Program, Industrial Visits, Lectures, Workshops, National/International seminars, conferences, Consultancy Work, Simulation/prototyping and tasks related to designing and engineering drawing.
 - (d) Identifying the real-world applications for the exploratory research/project works which have already been completed by scholars/students/professors and providing problem statements from various sectors based on which collaborative research can be carried out.
2. In order to carry out the above-mentioned activities, a detailed plan with timelines and responsibilities may be agreed upon in consultation between both the parties for every project or program, as necessary. A 'Scope of Work' document will be prepared and mutually agreed upon by both parties before commencement of the work.

3. It is implicit that each and every activity initiated under this agreement is mutually agreed, in writing by the authorized representatives of both the organisations which will also cater for their independence and mutual understanding in terms of Finances, Intellectual Property Rights and Confidentiality. Following are a few of the responsibilities to be undertaken by both the parties:

Scope & Responsibility of PRIST

- (i) To provide lab facilities & infrastructure required to carry out R&D, Simulation and Prototyping as applicable by the associates of BRIDGE Bharat Council involving Team PRIST which includes all the campuses situated in various locations, as required.
- (ii) To provide opportunity and infrastructure to BRIDGE Bharat Council and their associates to conduct Technical/Soft Skill Training, Seminar & Guest lecturers related to project related topics including Aerospace/Defence and other technologies, as applicable
- (iii) To partner with BRIDGE Bharat Council or its associates for the industry related works or projects undertaken by the students under SERB/DST, TDF/DRDO or any other initiatives of government or non-government and foreign agencies, as applicable
- (iv) To assist in documentation & IPR filing of Projects, R&D Works, developed by either/both parties.
- (v) To extend support to the Associates of BRIDGE Bharat Council in designing and development of Make in India projects, as required, WITHOUT INFRINGEMENT of Non-Disclosure Clauses and IPR provisions.


Scope of BRIDGE Bharat Council

- (i) To facilitate industrial visits, project participation, in-plant training for students and to provide career guidance, counselling and placement of students of all the PRIST institutions
- (ii) To conduct/ facilitate workshops, guest lectures, provide technical knowledge as related to project or other relevant areas within the ambit of the scope of work of the collaboration
- (iii) To provide consultancy services and support for curriculum development and Faculty Development Program (FDP) on latest trends in relevant technical domains, as per mutually agreed Terms & Conditions.
- (iv) To provide guidance and support to the faculty/students who apply for various projects for the funding by DST or Defence organisations, as applicable.
- (v) To guide and support the innovators of PRIST to develop/fabricate prototype and in commercializing their products/projects, through associates of BRIDGE Bharat Council.
- (vi) To support PRIST in their mission to establish a infrastructure for developing newer technologies related to cyber security, aerospace and defence.
- (vii) To educate and equip the professors and students about the Govt. e Market Place (GeM), Defence Procurement Manual and Defence Acquisition Plan.

4. This agreement shall be effective on and after the date of its signing by the authorized representatives of the two organisations and shall remain in force for a period of three years. It will be deemed to be renewed at the end of this period unless terminated explicitly by either party as per the stipulations mentioned hereunder. In order to terminate it before the end of this period, either party should give a three months prior written notice, subject to mutual agreement in respect of common obligations such as ongoing projects, warranty related commitments, disposal of shared resources, funding etc. to mutual satisfaction.

5. **Confidentiality and Non-disclosure.** Both the parties hereby guarantee that all the technical information, confidential information concerning data generated during the course of this agreement shall be of utmost confidentiality.

Either party shall not make/be permitted to take copies or other reproduction of the confidential information and same shall not be used commercially or academically unless provided for in the project agreement or assignment document. No such information shall be divulged without written consent of the parties even after the expiry of this agreement. Each party agrees to use all reasonable means, not less than those it employs itself to preserve and safeguard its own confidential information, to maintain the other party's Confidential Information secret and confidential. Each party agrees that the other party's Confidential Information shall not be disclosed or revealed to anyone except its authorized employees and nominated professional advisors who have a need to know the information and who have been advised of the confidential nature of the information and that the information shall be treated accordingly. Each party shall be responsible for the use or disclosure of the other party's confidential information by any of its employees or advisors.

6. This agreement is generic in nature and joint venture or specific projects to be undertaken in collaboration with any of the stakeholders of PRIST departments viz Vice Chancellors, Deans, Directors, HoD, Professors, students shall be governed by the additional terms and conditions, if any, and a clearly documented 'Scope of work' list, mutually agreed upon by both the parties. Either of the parties can use the other party's logo/crest for legitimate publicity and promotional activities after obtaining permission in writing from said party. The terms and conditions of this agreement also may be modified at any time after due consultation between both the parties and



Whereas PRIST Deemed To Be University, a accredited private Higher Education Institution in India (herein after referred to as PRIST) and Wollo University in Ethiopia (herein after referred to as WU) are linked by common academic and cultural interests; and

Whereas these two institutions wish to enable cooperation and exchange in all academic areas of mutual interest; and

Whereas these two institutions wish to expand the basis for friendship and educational exchange between India and Ethiopia;

THE PARTIES, PRIST AND WU HAVE REACHED AN UNDERSTANDING as follows:

**ARTICLE I
AREAS OF COOPERATION**

The purpose of this MoU includes, but not limited to, the following:

1. The development of collaborative teaching and research projects.
2. The organization of joint academic and scientific activities, such as twinning programs, conferences, seminars, workshops, symposia or lectures.
3. The exchange of research and teaching personnel.
4. The exchange of publications and other academic materials of common interest.



5. The exchange of students.
6. Creation of Centres of Excellence in specialized fields of mutual interest in Science, Engineering, Technology, Management and Humanities, and other fields of study.

Cooperative projects under this MoU may include any of the academic disciplines represented at either of the two institutions.

ARTICLE II LETTER OF AGREEMENTS AND IMPLEMENTATION

In order to carry out and fulfill the aims of this MoU PRIST and WU will appoint an appropriate person each of their campuses to coordinate the development and conduct of joint activities. Through these contact persons, either institution may initiate proposals for activities under this MoU. Specific details of any activity will be set forth in a letter of agreement, which, upon signing by appropriate authorities at both universities, and approved pursuant to Article IV, will become an integral part of this MoU. Letters of Agreement will include such items as:

1. Elaboration of the responsibilities of each institution for the agreed-upon activity.
2. Schedules for the specific activities.
3. Budgets and sources of financing of each activity.
4. Any other items necessary for the smooth and efficient conduct of the activity.

The contact persons will additionally be responsible for the evaluation of activities under this MoU according to the practices of their respective institutions. Letters of Agreement will be approved at each institution according to the normal procedures governing the types of activities proposed therein.

ARTICLE III COORDINATORS' RESPONSIBILITIES

Each institution shall designate a coordinator to oversee and facilitate the implementation of this MoU. The coordinators, working with other appropriate administrators at the respective universities, shall have the following responsibilities:

1. To promote academic collaboration at both universities, Ph.D, graduate and undergraduate student levels for research and study.



2. To act as principal contact / focal point for individual and group activities and to plan and coordinate all activities within their institutions as well as with the partner institution.
3. To facilitate cooperation for the purpose of funding of doctoral students to study at both institutions.
4. To initiate short-term training of Academic and Administrative personnel in both institutions.
5. To exchange information about faculties, facilities, research, publications, library materials and educational resources of the other institutions; and
6. To meet periodically to review and evaluate past activities and work out new ideas for future cooperative agreements.

National regulations and customs shall be mutually respected while discharging the responsibility for implementation of activities.

ARTICLE IV MoU AS PARENT DOCUMENT FOR PROGRAM AGREEMENTS

This general MEMORANDUM OF UNDERSTANDING shall be identified as the parent document of any program agreement executed between the parties. Further letters of Agreement concerning any program shall provide details concerning the specific commitments made by each party and shall not become effective until they have been reduced to writing and executed by the duly authorized representatives of the parties. The scope of the activities under this MoU shall be determined by the funds regularly available at both institutions for the types of collaboration undertaken and by financial assistance as may be obtained either institution from external sources.

ARTICLE V FINANCIAL ARRANGEMENTS

1. Except as may be stipulated in any specific program agreement, each institution shall be responsible for expenses incurred by its employees under this MoU.
2. Applications for financial support towards the cooperation and individual activities planned under this agreement will be transparent and undertaken with mutual consent.
3. Other sources of finances raised to support joint projects / activities can be pursued with the knowledge of the other through intimation in writing.



**ARTICLE VI
IMMEDIATE AREAS OF COOPERATION**


- Faculty and Student Exchange / Mobility Programmes
- Joint Academic Programs (Mechanical, electrical, civil Engineering, IT & Computer Science, and Management Studies: Human Resource, Accounting & Finance, Marketing, and other fields)
- Capacity Building of Faculty from WOLLO University at PRIST Deemed To Be University (pursuing Masters and/or Ph.D at PRIST Deemed To Be University)
- Joint Research, Training, Conference, seminar, workshops in the areas of mutual interest
- Doctoral Programs guidance by PRIST and/or joint Doctoral guidance.


This agreement shall become effective from today the 04.07.2020 upon signing of this MOU.

**ARTICLE VII
ENTRY INTO EFFECT AND DURATION**


Upon approval by each institution, this MoU shall remain in effect for a period of five (5) years unless terminated earlier by either institution. Such termination by one institution shall be effected by giving the other institution at least *ninety (90) days* advance written notice of its intention to terminate. Termination shall be *without penalty*. If this MoU is terminated, neither PRIST nor WU shall be liable to the other for any monetary or other losses which may result.

The current members of the Organisation are Bangladesh, India, Maldives and Sri Lanka while Indonesia, Malaysia, Myanmar and Thailand are cooperating non-contracting parties.

The core objectives of the BOBP-IGO are to increase awareness and knowledge of the needs, benefits and practices of marine fisheries management; enhance skills through training and education; transfer appropriate technologies and techniques for development of the small-scale fisheries; establish regional information networking; and promote women's participation in marine fisheries value chain.

The Organisation evolved from the erstwhile Bay of Bengal Programme of the Food and Agriculture Organization (FAO) of the United Nations (UN) founded in 1979. 

The institute envisions being an internationally recognized Institution for its excellence of academic programs, for its high quality teaching across a broad range of disciplines, promoting world class research and community service in making quality and flexible higher education to reach wider community.

This MoU is being signed between Bay of Bengal Programme Inter-Governmental Organization, hereafter referred as BOBP-IGO and Ponnaiyah Ramajayam Institute of Science and Technology, hereafter referred as PRIST.

1. BOBP-IGO and PRIST desire and intend to develop co-operation and collaboration in research, policy advocacy, capacity building, training, education and other agreed activities that further the following aims and objectives of both the parties, as within the limitations of the concerned Institutions' resources, policies and procedures.
 - 1.1. To encourage and use their reasonable endeavours, visits from one Institution to the other by the staff members for participating in teaching, training, research for development programs and other agreed activities.
 - 1.2. To develop joint work programs through knowledge networks with clear objectives and targets, implementation mechanisms, roles and responsibilities, and resource contributions.
 - 1.3. To jointly explore external funding opportunities through project proposal development, thus enabling both parties to expand and extend their collaborative activities.
 - 1.4. To institute an enabling mechanism for exchange of students and researchers between the organizations from the member countries
 - 1.5. To encourage the exchange of scientific material, publications and information, within the overall institutional governance frameworks.
 - 1.6. To conduct jointly subject-matter lectures and organize symposia, seminars, workshops, etc.
2. The collaboration may take any form, as illustrated below, but not limited to them.
 - 2.1. **Collaborative Research Networks:** Both parties shall facilitate in forming research networks comprising researchers (faculty/scientists/scholars) from their own organization and also from their pre-established partnerships, including those from other countries in the region and/or UN organizations.
 - 2.2. **Virtual Research / Policy Circles:** Both parties shall undertake joint research studies in prioritized areas by leveraging their respective strengths. The IGO shall

facilitate in forming thematic circles comprising the researchers from both parties along with the researchers from other countries in the region and/or UN organizations.

- 2.3. **Joint Capacity Building Programs:** Both parties shall liberally facilitate in enabling the pool of experts under their rolls and also in their networks to be part of the capacity building/training programs as resource programs in the joint or independent programs conducted by the respective parties.
 - 2.4. **Research Fellows:** The scholars pursuing research for their academic programs in the field of marine fisheries resource management and social sciences shall undertake research on regional / global sustainable fisheries management and associated livelihood and policy issues under the guidance of internal or external expert networks of the IGO as a part of regional network projects implemented by BOBP.
 - 2.5. **Exchange of Resources:** Both parties shall jointly develop a framework for short-term faculty/researchers/students exchange between the research and academic organizations located in the region. Further, the University shall earmark few seats in their graduate and post graduate programs as priority seats for admission to the students from the member countries. BOBP shall facilitate in developing a reciprocal mechanism in the organizations in the member countries, through the respective governments.
 - 2.6. **Sharing Expert Services:** The quality of the services of communication and documentation unit of BOBP are well recognized, which are availed by many national and international organizations on specific charges. BOBP shall extend its services as a Communication Partner for the University, for its events/programs/activities, on tailor-made specialized terms.
3. Both parties acknowledge that the collaborations shall accrue mutual benefits and both parties shall strive to add value to the partnership, based on their own spheres of expertise. With regard to any potential intellectual property resulting from the research collaborations, each party under the MoU will be entitled for an equitable and fair agreement as to the ownership.
 4. Both parties acknowledge that in the absence of any specific agreement to the contrary, each party will commit its own costs of complying with the obligations under this MoU.
 5. This document is not intended to create legal or binding obligations on either party. It serves only as a record of the parties' current intentions. Notwithstanding anything contained in this MoU, the organizations will be bound by the regulatory and legal frameworks governing them, as revised from time to time.
 6. This MOU commences from the date of last signing and shall be in force for 5 years. The MOU may be terminated at any time by mutual consent or with 6months advance notice by either party. It may be amended, modified, extended, or renewed only by the written consent of both Parties. In the event of termination of this MoU, any other separate



agreement(s) related to the subject of this MoU between both the parties shall not automatically terminate. Both the parties agree to review this MOU, six months prior to end of the 5-year term. No confidential information including data-use shall be exchanged pursuant to this MoU without proper agreement between the concerned parties.

7. The specific terms of this MOU do not preclude the development of future collaborative ventures or projects not mentioned in this document.






CLAUSE 1
