YEAR 2018-2019**




- During the introductory session, Dr. L. Chinnappa, Chair of the Anti-Ragging Committee, provided a detailed overview of each member's responsibilities in addressing ragging complaints within the institution. The session emphasized the committee's mission to create and maintain a safe and supportive environment for students. Dr. Chinnappa highlighted the critical role each member plays in this effort and the importance of vigilance and responsiveness in dealing with any issues that arise.
- To reinforce the institution's commitment to preventing ragging, anti-ragging signage and posters have been strategically placed across key locations on campus. These include the cafeteria, classroom walkways, restrooms, and canteens. This widespread visibility aims to ensure that all students are aware of the anti-ragging policies and the serious consequences of such behavior.
- In addition to these measures, surprise inspections were carried out by vigilance officers in various areas of the campus, including hostels and buses. These inspections were conducted to ensure compliance with anti-ragging regulations and to deter potential incidents. Fortunately, no instances of ragging were reported during these checks, reflecting the effectiveness of the vigilance system.
- The committee has also confirmed that all students and their parents have completed the necessary anti-ragging affidavits, affirming their commitment to preventing ragging. On December 21, 2018, an anti-ragging awareness program was organized to further educate the campus community on the importance of maintaining a harassment-free environment.
